The heavy-handedness of those pushing health care reform through Congress has been disturbing to watch. Just as bad will be the setbacks that will be dealt to Ohio's efforts to create jobs and revive our economy.

Instead of working to build consensus, President Obama and the Democrats in Congress have taken the divisive approach of forcing their own top-down, one-size-fits-all vision on America.

At a time when Ohio desperately needs new jobs, the bill undermines job-creating efforts by imposing more than \$560 billion in new taxes on the very things that will revive the economy—small businesses and investment.

If that weren't enough, the bill also worsens the long-term budget health of the United States. The new taxes will hurt long-term economic growth and, if history is a guide, won't be enough to pay for all the new spending. In the end, the federal government will just rack up higher deficits and go deeper in debt, leaving future generations to pick up the tab.

Ohio government spending will go up also, adding to an already bleak budget picture. Instead of letting states develop innovative solutions to their respective challenges, new federal mandates will require more Medicaid spending and stick states with large and unsustainable costs.

I want to see every Ohioan have health coverage, and a better way to start would be to simply eliminate the frivolous lawsuits that drive up costs, allow health care companies to compete across state lines, and end pre-existing condition rules that keep people from the care they need. What we got instead was a bill that will kill jobs and give government politicians and bureaucrats greater control over our personal health care decisions.



"Virginia's attorney general, Ken Cuccinelli II, has said he will file a legal challenge to the bill, arguing in a column this month that reform legislation 'violate[s] the plain text of both the Ninth and Tenth Amendments."

"Article I of the Constitution allows Congress to tax and spend to 'provide for the common defense and general welfare of the United States.' Normally, this is no barrier to legislation benefiting a particular state or city. Congress can always argue that, say, an Air Force base in Nebraska benefits the United States as a whole. But the deals in the Senate bill are different. It is really hard to identify a benefit to all the states from exempting one state from an increase in Medicare costs or allowing only the citizens of Florida to get Medicare Advantage."



I am tired of those who complain that their premiums will increase because insurance companies now have to insure those with pre-existing conditions. Take a look at how much premiums have increased with all those people being denied coverage. A 130% increase in the last ten years, that is how much rates have increased, and it was likely to continue at that pace without some drastic reforms.

Here is my story. I had insurance. I am and have been self-employed for many years. I had a private plan through Anthem in Colorado. Then, I was diagnosed with hemochromatosis which resulted in the development of cirrhosis of the liver. Luckily, it is very early stage, and since the cause has been addressed, which was too much iron in my body, I should be able to live with it without it becoming worse.

However, for personal reasons, I moved here to Ohio. Upon moving, Anthem told me that I would be given a policy in Ohio similar to the one I had in Colorado, even with my pre-existing conditions, because supposedly Anthem had a reciprical agreement with Anthem in other states. In the end, all Anthems are owned by Wellpointe. Well guess what? They denied me coverage. I had coverage for years in Colorado with them, but now, given the opportunity, they got me out of their system, because I am now too high of a risk.

Now, to be fair, I was offered a guaranteed issue policy. Of course, it was nowhere near as good as my old policy. It had a lower lifetime limit of \$1 million, and the deductible was \$3500, and of course, the premium was \$900 per month, just for me. Basically, it would cost me over \$14,000 per year, just for myself. On top fo that, they wanted to double the rates on my two boys. Luckily, Aetna insured my boys for bout the same amount as in the past. My old policy cost me \$350 per month with a \$1000 deductible.

This is how the insurance companies operate. Instead of finding ways to actually reduce costs, they just cut coverage to anyone who becomes to expensive. This is not the way insurance was meant to work. If insurance companies only want to insure healthy people, then we need a real change, and hopefully this new healthcare legislation is the beginning.

Now, let me tell you a story about costs. This is something that truly upsets me, and it shows how screwed up this current system is. It also tells me that costs can be reduced dramatically if billing paperwork was reduced, and their was more competition in medicine in general. The treatment for hemochromatosis is the removal of iron from the body, which is accomplished through phlebotomies (removal of blood). Over 18 months, they took 90 pints of blood out of me to remove all of the iron. Now, I just need to have a phlebotomy once every three months or so to keep my iron levels normal. But here is what I learned. Since I now have to pay out of my pocket for my treatment, I looked around. What I found is quite frustrating. When my insurance company was paying for the phlebotomies, they paid approxiamately \$400 per phlebotomy. The hospital actually billed around \$600, but the insurance only paid \$400. By paying cash, I get the same exact treatment for \$150. So how is it that the same treatment can be done for basically one third of the cost? And how many other medical procedures could actually be done for half or one third of what we are currently charged?

There are answers out there to reduce costs without lowering quality of service, but under the current system, there are no incentives to reduce those costs. The stupid thing is that nobody talks about any of this. Whichever side you talk to, you get one blanket answer, and neither side has an effective answer to reduce costs because everyone is trying to protect their own interests rather than finding solutions that will benefit everyone.

So in the end, I'll take this new legislation. It won't reduce costs, but at least I will be able to purchase insurance again at a fair price. I didn't choose to become sick, and being denied coverage even when I had coverage in the past just shows how bad our current system is. That on top of the massive increases in premiums is more than enough proof to me that the old way is not doing anyone any good.



Man-made global warming is mostly a myth. I calculate that at best, the rate of burning of fuels may raise the average global temperature by one degree Fahrenheit. If we stopped burning the stuff, that degree would go away.

Increased carbon dioxide in the air has little or no effect on weather. Water & water vapor (moisture, humidity, clouds) are the DOMINANT greenhouse gas. They are totally responsible for "weather" as we know it. Carbon dioxide only has an effect in the stratosphere and upper atmosphere where ther is little or no water vapor. So, adding more carbon dioxide in the air, after it migrates up there, will heat the upper atmosphere a bit more in the daytime, and cool it more at night. It also may mean warmer summers and colder winters... perhaps by the one degree Fahrenheit I mentioned. Not a big deal. On the average, it's a "zero-sum game". So the best thing to do is ignore the whole greenhouse issue. Period. Wast not one penny more on that myth.

Because of this myth, Carbon Sequestration is pure FOLLY. Waste no more tax dollars on such insanity. Power companies are now wasting millions of dollars of subscriber money and federal funds chasing this ghost. Cease and desist, I say.





The Truth About the Health Care Bills – Michael Connelly, Ret. Constitutional Attorney

Well, I have done it! I have read the entire text of proposed House Bill 3200: The Affordable Health Care Choices Act of 2009.. I studied it with particular emphasis from my area of expertise, constitutional law. I was frankly concerned that parts of the proposed law that were being discussed might be unconstitutional. What I found was far worse than what I had heard or expected.

To begin with, much of what has been said about the law and its implications is in fact true, despite what the Democrats and the media are saying. The law does provide for rationing of health care, particularly where senior citizens and other classes of citizens are involved, free health care for illegal immigrants, free abortion services, and forced participation in abortions by members of the medical profession.

The Bill will also eventually force private insurance companies out of business, and put everyone into a government run system.. All decisions about personal health care will ultimately be made by federal bureaucrats, and most of them will not be health care professionals.

Hospital admissions, payments to physicians, and allocations of necessary medical devices will be strictly controlled by the government.

However, as scary as all of that is, it just scratches the surface. In fact, I have concluded that this legislation really has no intention of providing affordable health care choices. Instead it is a convenient cover for the most massive transfer of power to the Executive Branch of government that has ever occurred, or even been contemplated If this law or a similar one is adopted, major portions of the Constitution of the United States will effectively have been destroyed.

The first thing to go will be the masterfully crafted balance of power between the Executive, Legislative, and Judicial branches of the U.S. Government. The Congress will be transferring to the Obama Administration authority in a number of different areas over the lives of the American people, and the businesses they own.

The irony is that the Congress doesn't have any authority to legislate in most of those areas to begin with! I defy anyone to read the text of the U.S. Constitution and find any authority granted to the members of Congress to regulate health care.

This legislation also provides for access, by the appointees of the Obama administration, of all of your personal healthcare direct violation of the specific provisions of the 4th Amendment to the Constitutioninformation, your personal financial information, and the information of your employer, physician, and hospital. All of this is a protecting against unreasonable searches and seizures. You can also forget about the right to privacy. That will have been legislated into oblivion regardless of what the



3rd and 4th Amendments may provide.

If you decide not to have healthcare insurance, or if you have private insurance that is not deemed acceptable to the Health Choices Administrator appointed by Obama, there will be a tax imposed on you. It is called a tax instead of a fine because of the intent to avoid application of the due process clause of the 5th Amendment. However, that doesn't work because since there is nothing in the law that allows you to contest or appeal the imposition of the tax, it is definitely depriving someone of property without the due process of law.

So, there are three of those pesky amendments that the far left hate so much, out the original ten in the Bill of Rights, that are effectively nullified by this law It doesn't stop there though.

The 9th Amendment that provides: The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people;

The 10th Amendment states: The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are preserved to the States respectively, or to the people. Under the provisions of this piece of Congressional handiwork neither the people nor the states are going to have any rights or powers at all in many areas that once were theirs to control.

I could write many more pages about this legislation, but I think you get the idea. This is not about health care; it is about seizing power and limiting rights. Article 6 of the Constitution requires the members of both houses of Congress to "be bound by oath or affirmation to support the Constitution.." If I was a member of Congress I would not be able to vote for this legislation or anything like it, without feeling I was violating that sacred oath or affirmation. If I voted for it anyway, I would hope the American people would hold me accountable.

For those who might doubt the nature of this threat, I suggest they consult the source, the US Constitution, and Bill of Rights. There you can see exactly what we are about to have taken from us.

Later when we didn't receive the, promised, timely confirmation it resulted in no Medicare coverage to date.

I was informed by my employer that I was entitled to unemployment pay. Went through the same hassel with that. 
